

INFORMATION NOTICE ABOUT PERSONAL DATA PROCESSING

Your personal data will be processed as follow:

Data controller

The data controller is the company CIBER s.r.l. with registered office in Via Lazzaro Spallanzani n.8, 24061, Albano S. Alessandro, BG, Italy.

Purpose of the processing and legal basis

Your personal data is processed:

- Without your express consent, for the following purposes:
 1. acquisition of preliminary information for the provision of our service/product (ex. estimates);
 2. management of pre-contractual relations;
- Only with your specific consent for the following purpose:
 3. sending commercial communications and advertising material on products/services offered (ex. newsletter, e-mails, etc.);
- For the legitimate interest of the company CIBER s.r.l. to inform potential customers about the products/services offered, for the following purposes:
 4. sending presentations of the company's activity aimed at evaluating collaborations; you may request not to receive further sales communications.

Nature of data provision and consequences of refusal to respond

The provision of data for the purposes referred to in point 1. and 2. is mandatory. In their absence, we will not be able to guarantee the services requested.

The provision of data for the purposes referred to in points 3. and 4. is instead optional.

You can therefore decide not to provide any data or subsequently deny the possibility of processing data already provided; in this case, you will not be able to receive newsletters, commercial communications and advertising material relating to the services offered by CIBER s.r.l.

Processing methods

Personal data processing is carried out by means of the operations indicated in art. 4 n. 2) GDPR and more precisely: collection, recording, organization, storage, consultation, modification, use, communication, disclosure by transmission, dissemination or otherwise making available, alignment or combination, deletion or destruction. Your personal data is subject to both paper and electronic and / or automated processing.

Data retention

The Data Controller will keep the personal data for no more than 2 years from the collection of consent for marketing purposes.

Data communication

Your data may be made accessible:

- to employees, collaborators of the Data Controller;
- to professional firms, consultants, providers of installation services, assistance and maintenance of IT and telematic systems and systems, system administrators, who carry out outsourced activities on behalf of the Data Controller in their quality of data processors; to public authorities and administrations.

Rights of the data subject
